Senator Wyden Wallowa County Town Hall: Oct. 2 at 1:30pm PT

Senator Wyden is doing a second 2022 Wallowa County Town Hall! The event takes place on Sunday, October 2nd at 1:30pm PT. <u>Here is the link to watch</u>.

One advantage we have living in a small community is the opportunity to talk directly with the Senator. You can <u>put your name in to ask a question or make a comment here</u>. All you have to do is fill out the form and note the topic of your question. A third party chooses the questions, generally on a first-come first-served basis, so don't delay! If you're selected, you'll be contacted prior to the event.

If conservation, environmental justice, and wildlife are on your mind, consider asking a question about the Senator's commitment to restoring the Eastside Screens protections for large and mature trees across Eastside Forests, express your support for the River Democracy Act by asking about the next steps for passing the legislation in the next session, or share your input on why breaching the Lower Snake River Dams are critical to providing fish passage for salmon and steelhead in the many Snake River tributaries in Eastern Oregon.

Pew Charitable Trust engages on the outdated Blue Mountains Forest Plan

Pew recently contracted with Conservation Science Partners to evaluate the high ecological value areas of national forests in the Blue Mountains. The effort hopes to identify the 10% of unprotected land areas in the region that are most in need of protection, and to ensure that these values are considered when the long-outdated forest plans are updated. As we shared last month, the U.S. Forest Service is restarting the Blue Mountains Forest Plan revision process for the Wallowa-Whitman, Malheur and Umatilla national forests. It's heartening to see organizations such as Pew recognize the ecological importance of the national forests across the Greater Hells Canyon Region. Read the full article here.

Oregon Supreme Court affirms state forests are not only for logging

The Oregon Supreme Court declined to hear the appeal from Linn County and other so-called timber counties' who claim to be owed \$1B for lost revenues from declining clearcuts and logging projects. It leaves the lower court ruling in place that effectively affirms that Oregon's state forest lands can be managed for more than just timber production — that recreation, clean water, wildlife habitat and additional uses have value that are also worth protecting.
