Spring on the Blue Mountains Trail

Spring arrives with a bloom of news from the Blue Mountains Trail. In March <u>we published a new interactive map</u> showing the full trail route in detail. After four months soliciting and reviewing route feedback, the proposed route has been shortened to 530 miles, but the new route also removed many of the miles that were on pavement and some of the busier gravel roads.



We were also awarded funding from Travel Oregon as a Destination Ready project for work that will happen between now and the end of September. This will be instrumental for developing improved mapping for the trail and hiker-focused town guides for the communities on the route,

getting hiker materials ready for this summer and fall. It also will enable us enlist hiker support for trail maintenance this summer.


Five Wolves Found Dead in Union County

Oregon Fish and Wildlife officials reported that five wolves were found dead in the Mt. Harris area of Union County in Northeast Oregon on February 9. Officials said all five carcasses were taken to the U.S. Fish and Wildlife forensic lab to determine the cause of death, and the incident remains under investigation. Survey Seeks Public Input on the Morgan Nesbit Proposed Timber Sale

The Wallowa-Whitman National Forest is currently in the planning stages of the Morgan Nesbit Forest Resiliency Project, a proposed 87,000 acre timber sale east of Joseph and bounded by the Imnaha River. The agency has created a <u>very brief survey</u> to learn more about how the general public values and prioritizes ecosystem services in the area.
